AN ORDINANCE OF THE CITY OF ARANSAS PASS, TEXAS GRANTING A ONE (1) MONTH CONDITIONAL USE PERMIT TO LIVE IN AN RV SITUATED AT 860 S. MCCAMPBELL STREET UNTIL HOUSING IS OBTAINED.
