ORDER AUTHORIZING CITY OF ARANSAS PASS
TO DEMOLISH STRUCTURE OF PROPERTY

On December 6, 2022, the Building Board of Standards and Appeals ORDERED that the structure (s) and any accessory structure (s) located at 503 S 10th Street, Aransas Pass, Texas, be demolished by the owner(s), mortgagees, lienholder (s) or other persons having an interest in the structure withing 30 days.

A copy of the Board's order was mailed to each known owner, mortgagee, lienholder or interested party, via certified mail, return receipt requested, within 10 days of the Board's issuance of the order. A copy of the order was posted on the Property and relevant portions of the order, as dictated by laws, were published in the January 4, 2023 and January 11, 2023 edition of the Aransas Pass Progress.

Following the lapse of 30 days from the Board order, the above referenced was reinspected and the structure (s) and accessory structure (s) was found to be standing, in the same condition, on the property.

The Board now ORDERED that if said persons having to fail to abide by the order, within the allotted time, the City of Aransas Pass, through its agents and contractors, is authorized to enter the Property, demolish the structure (s) and any accessory structure (s) on the Property, remove all components and personalty, and place a lien on the Property where allowed by law for its incurred expenses.

It is therefore ORDERED that the City of Aransas Pass is authorized, through its authorized agents and contractors, to: 1) remove doors, dates, windows, locks, walls, boards and other barriers preventing entry onto the Property; 2) enter the Property to inspect, photograph, and measure for purposes of documentation; 3) demolish the structure (s) and any accessory structure(s) on the Property; 4) remove all components and personalty; and 5) place a lien on the Property where allowed by law for the City's incurred expenses.
